You are cordially invited to participate in Downtown Gainesville's 10<sup>th</sup> Annual Juried **Art In The Square** on Saturday and Sunday, September 21-22, 2013, sponsored annually by the Art In The Square Association and Main Street Gainesville.

The festival will take place on the Square in beautiful Downtown Gainesville from 10:00 am to 5:00 pm on Saturday and from 11:00 am to 5:00 pm on Sunday. Booth set up will take place between 8:00 and 10:00 am on Saturday. There will be professional artists in all media from Gainesville/Hall County and the surrounding region displaying and selling their work. Games, music and food from the many downtown restaurants will make this an unforgettable event. Over \$1500.00 in awards will be given by judge Craig Wilson, MFA, Gallery Director at the University of North Georgia.

A selection committee (jury) will determine who will be accepted for this festival. Therefore, all artists must submit a completed application form - please fill out **all** information (page 2), a \$10 check for juried entry fee (non-refundable made out to Main Street Gainesville), a CD or 3-5 photos of your work and booth, and the waiver of liability form (page 4) by **July 1, 2013**. Artists are responsible for providing their own 10' by 10' tent (no tents will be available for rental). Artists will be notified of acceptance within two weeks after your application is received. There are a limited number of booths per category; booths are assigned to accepted artists on a first come, first served basis. Additional information, directions and instructions will be communicated in August.

Please complete pages 2, 3 and 4 (signature required at bottom of each page) and keep copies for your records. Mail completed forms along with your business card (if applicable) and your check for the entry fee to the address below.

## RULES AND REGULATIONS

### 10<sup>TH</sup> ANNUAL ART IN THE SQUARE FESTIVAL September 21-22, 2013

Please read the following rules and regulations for the *ART IN THE SQUARE FESTIVAL* before filling out and submitting your application.

#### **ENTRY REQUIREMENTS:**

1. Submit up to 5 photos of the work you will be displaying including one of your booth set-up.
2. Enclose a check for the jury fee and once accepted, please remit booth fee and table/chair rental fee (if needed).
3. Complete and sign Exhibitor Application, Rules and Regulations and Waiver of Liability. All forms must be signed if you wish to participate in the festival.

**DEADLINE FOR APPLICATION IS JULY 1, 2013**

#### **BOOTH SIZE AND FEES:**

Your exhibit space will be approximately 10' x 10'. The booth rental fee is \$110 for Saturday and Sunday. More than one booth space may be rented. Tables (6' rectangular) and 2 chairs may be rented for an additional \$15.00. The Art in the Square Association will not charge commission on art work sales.

#### **TAXES:**

Exhibitors are responsible for collecting and reporting Georgia Sales Tax (7%) on all sales, if applicable. This amount may change before the time of the festival.

#### **SECURITY:**

Gainesville Police will be on duty from Saturday 6pm until Sunday 10am. However, we cannot be responsible or liable for any injury in your booth to any customer or exhibitor and/or, loss or damage to property in your booth for any reason. You will be responsible for securing your booth and contents in the evening, any insurance coverage for your personal property and/or injury to any customer/persons in your booth.

#### **DISPLAYS, TABLES AND CHAIRS:**

Exhibitors must bring their own display materials such as easels, display screens, etc. All tables must be draped to the floor on all sides (you may use tablecloths or sheets). Booths must be kept clean at all times, and must be left clean at the end of the festival. All items not displayed must be kept under your tables and out of sight.

PLEASE LEAVE YOUR BOOTH AREA CLEAN!

#### **SET-UP AND BREAKDOWN:**

Set-up begins Saturday at 8:00 AM. You should have your area ready to greet customers by 10:00 AM. Show hours are from 10:00 AM – 5:00 PM on Saturday and 11:00 AM – 5:00 PM on Sunday.

This is a binding contract. All displays must remain set up until the close of the festival date for which you have registered. Failure to do so will forfeit any eligibility for future participation.

Artists are solely responsible for the set up and break down of their own booths. Any volunteers assisting the Art in the Square Association are provided as a *courtesy* and are not required to assist artists or handle art work. If you choose to utilize any volunteer you do so at your own risk, they are not responsible for any loss or damage.
