

City of Gainesville Multi-Family/Commercial Plumbing Retrofit Program Information and Requirements

This rebate program is open to all Multi-Family and Commercial Department of Water Resources Customers. The following requirements **MUST** be followed to be eligible to participate in the rebate program. A 75 dollar credit will be added to the water account for each eligible* toilet replaced. **The number of rebates given per year to a single location and/or customer is limited and will be determined based on the available funds.** The number of rebates a customer can receive will be determined after an initial inspection and prior to toilet replacement.

Rebate Requirements:

1. Building(s) must be built prior to 1993. (according to the tax assessor's office)
2. **An initial site inspection must be conducted BEFORE the current toilets are replaced.**
3. Current toilets must be 3.5 gallons per flush or greater.
4. Once an initial site inspection has been completed the number of rebates the property is eligible for will be determined.
5. A **1.1 gallon per flush or less toilet bearing the WaterSense label must be installed.**
6. After replacement, current toilets must be disposed of so they may not be reused.
7. A post replacement inspection must be performed after toilets have been replaced. Rebates will not be granted to an account before a post replacement inspection occurs.
8. The rebate application must be completed. Rebate application can be obtained at the initial site inspection.

*An eligible toilet is one that has been verified to be 3.5 gallons per flush or greater during the initial site inspection. It has also been approved by the site inspector to be replaced under the rebate program. A toilet replaced **before** an initial site inspection is not eligible to receive a rebate.

1. A site inspection must be conducted before and after the toilets are replaced.
2. Building must be built prior to 1993. (according to the tax assessor's office)
3. Toilet being replaced (old toilet) must be 3.5 gallons per flush or greater.
4. A **1.1 gallon per flush** toilet bearing the WaterSense label must be installed.
5. Current toilets must be disposed of so they may not be reused.

**Please note that dual flush toilets that are 1.1/1.6 gpf do not qualify.*
