AN ORDINANCE TO AMEND CHAPTER 3-2, ENTITLED "POLICE DEPARTMENT," OF THE CODE OF ORDINANCES OF THE CITY OF GAINESVILLE BY ADDING SECTION 3-2-1, ENTITLED "ADMINISTRATION OF OATH OF OFFICE TO CITY POLICE OFFICERS;" TO AMEND CHAPTER 3-3, ENTITLED "FIRE DEPARTMENT," OF THE CODE OF ORDINANCES OF THE CITY OF GAINESVILLE BY ADDING SECTION 3-3-5, ENTITLED "ADMINISTRATION OF OATH OF OFFICE TO CITY FIREFIGHTERS;" TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE FOR SEVERABILITY; TO PROVIDE FOR CODIFICATION; TO PROVIDE FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.
