A. Ordinance No. 2019-24

Amend Title 6 Chapter 6-21 Entitled Small Wireless Facilities In the City Right of Way

AN ORDINANCE TO AMEND TITLE 6 ENTITLED "LICENSES, PERMITS AND BUSINESS REGULATIONS" OF THE CODE OF ORDINANCES OF THE CITY OF GAINESVILLE BY CREATING A CHAPTER 6-21 ENTITLED "SMALL WIRELESS FACILITIES IN THE CITY RIGHT OF WAY" TO IMPOSE APPLICATION, ADMINISTRATIVE REVIEW, AND OTHER REQUIREMENTS ON WIRELESS PROVIDERS WANTING TO COLLOCATE A SMALL WIRELESS FACILITY IN THE RIGHT OF WAY OR TO INSTALL, MODIFY, OR REPLACE ASSOCIATED POLES OR DECORATIVE POLES IN THE RIGHT OF WAY; TO AMEND CHAPTER 6-17 ENTITLED "USE OF CITY RIGHT-OF-WAY" OF THE CODE OF ORDINANCES OF THE CITY OF GAINESVILLE BY ADDING SECTION 6-17-8 ENTITLED "EXCEPTION;" TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE FOR SEVERABILITY; TO PROVIDE FOR CODIFICATION; TO PROVIDE FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.
